What is the NHS Finance Insights placement scheme?

The NHS Finance Insights placement scheme is a paid 12-month work opportunity for young people from lower socio-economic backgrounds. It's designed to give you real experience working in the finance department of an NHS organisation near where you live.

The NHS is not only a great place to work with good starting pay, yearly increases, and clear opportunities to progress, but it also gives you the chance to do something meaningful. By supporting NHS finance, you're helping the health service deliver care to thousands of people every day.

What you'll get from the scheme:

- 12 months of hands-on full-time experience in an entry-level finance role.
- A chance to rotate through different finance departments and projects.
- Flexible working, with time in the office and at home.
- Training, development, and events throughout the year.
- The opportunity to meet other trainees across England.
- Experience of working with a wide range of people across the NHS.
- A unique insight into how the NHS runs behind the scenes.

By the end of the placement, you'll have valuable skills, real work experience, and the confidence to apply for NHS apprenticeships, entry-level jobs, or other exciting career opportunities.

Entry requirements

The initiative aims to support individuals aged 18+ from lower socio-economic backgrounds, and applicants interested must meet the following criteria:

- Attending state school or college, or have been in full-time education within the past three years, minimum Grade C / 4 in GCSE Maths is desirable but not essential, *and*
- Not planning on attending university, *and*
- The occupation of your main household earner is categorised as a lower socio-economic background*, *or*
- Have been eligible for free school meals** at any point in the previous six years

**Parental occupation classification is a national standard, and the Social Mobility Work's toolkit ([found here](#)) provides details on the categorisations.*

***Free School Meals are a statutory benefit available to school-aged children from families who receive other qualifying benefits and who have been through the relevant registration process. It does not include those who receive meals at school through other means e.g., boarding school.*

We are also interested to hear about any extra-curricular activities and hobbies/interests that may help support an application.

If you are a care leaver then you will be guaranteed an interview, on the condition that you meet all the requirements and the application form is completed to a suitable standard.

Why apply?

The NHS is a great place to start your career journey, this programme is perfect for anyone interested in a future job working with numbers and computers.

During this programme, you will get to:

- **See what it's like to work in the NHS.** You'll join a finance team and work on different projects to learn how the NHS works as a business.
- **Work within a team.** You will work within a team, who help the NHS run smoothly.
- **Learn new skills.** You will learn how to use computers, work with spreadsheets, and how to organise and prioritise work tasks. All of these skills will help you in your future jobs.

If you enjoy working with people, like solving problems, and find working with numbers fun, this opportunity is perfect for you! You may not know what you want to do for a job yet, and that's okay. This placement can help you learn new things and give you the confidence to start your career journey.

Whilst this opportunity is a step before an apprenticeship or a full-time role, and does not include a qualification or guarantee a permanent job at the end of the 12 months, it provides invaluable real-world experience and will be highly beneficial when applying for future jobs and roles.

How to apply

To apply you must meet the entry requirements outlined on page 3 of this brochure and complete an online application form where you will be asked to provide your personal details and answer a few short questions about why you are applying for the placement scheme.

Please note this is a full-time role if you're considering applying.

Applications will open on the **1st of October, 2026** once applications are open, the application form will be live on the NHS Finance Insights placement scheme web page here: <https://financecareers.nhs.uk/opportunities/nhs-finance-insights-placement-scheme/>

Please complete and submit your application by the **7th of May, 2027**.

All applications will be reviewed and shortlisted. Shortlisted applicants will then be invited to attend a 30 minute interview in June and July. Following interviews, the successful applicants will be contacted via email to confirm their placement, ahead of beginning in September 2027.
